Drawing Date

The drawing dates and entry deadlines are subject to change at the sole discretion of the NCEL. Any changes will be announced by the NCEL at least seven (7) calendar days prior to the scheduled entry deadline date via the NCEL's official website (www.nclottery.com) and the information may also be obtained by calling the Customer Support Center at (866) 934-0289.

Winner

One (1) Mega Power Flash Second Chance Winner (the "Prizewinner") will be selected in one (1) second chance drawing to win \$25,000. The NCEL reserves the right, in its sole discretion, to substitute any prize with an alternate prize of equal or greater value.

Entry Eligibility Requirements

A valid entry shall follow the entry requirements herein and require a qualifying Mega Millions or Powerball draw game ticket, retail or Online Play, meeting the validation requirements of the NCEL. Entrants will receive one entry per qualifying ticket upon completing entry requirements.

- 1. Players may only enter the drawing by accessing the NCEL's Lucke-Rewards website at www.nclottery.com, entering the required player information and the twenty-five (25)-digit numeric entry number (Lucke-Rewards Entry Code) from eligible "Mega Millions" and "Powerball" Draw Game Tickets. Players may also enter the drawing by using the NCEL's NC Lottery Official Mobile App to scan the Lucke-Rewards barcode. Players will also earn an entry automatically when making eligible "Mega Millions" and "Powerball" Draw Game purchase in Online Play during the Promotion Entry Period.
 - The NCEL and its vendor(s) will not be responsible for data entry errors by entrants nor for connectivity issues involving the player's access to the NCEL's website or the Mobile App.

- An attempt to electronically submit an entry that has already been submitted will generate an error message informing the player that the entry has already been submitted and may not be resubmitted.
- 2. Entrants must be at least eighteen (18) years old to participate in this Promotion.
- 3. Entrants are subject to all NCEL Rules and Regulations, the North Carolina State Lottery Act, NCEL Terms of Service and Use, and the drawing procedures for the Mega Power Flash Second Chance Drawing Promotion and any applicable laws affecting this Promotion outside the State of North Carolina. - 7. Players may submit more than one (1) entry in the drawing. Prize winners are not eligible to win another Prize in this Second Chance Drawing Promotion.
- 8. Tickets determined to be in a stolen/missing inventory status or not part of a valid sold, activated or promotional NCEL inventory status will be disqualified.
- 9. Tickets for Mega Millions and Powerball draw games will continue to be sold after the drawing.

Claiming Requirements
